**MEETING CALLED TO ORDER:** Mayor Schell called the meeting to order at 5:31 PM. Councilmember Feist led the Pledge of Allegiance. Masks and physical distancing were recommended for those in attendance at City Hall.

<u>PUBLIC COMMENTS:</u> Dave Jensen stated that he didn't have enough information to provide public comment at that time and would reserve his right to provide public comment at a later date. There was no public comment on non-agenda items.

## **UNFINISHED BUSINESS:**

- 1. **Budget Introduction and Timeline** The timeline was in the council packet. Mayor Schell summarized what had been presented to date. There was no public comment. This was an information-only item.
- 2. **Review of Open Budget Questions** A list of open budget questions was in the council packet. Mayor Schell reviewed each. Council added the mayoral salary and cost-of-living adjustment to the list. Public Works Director Ore discussed updates to the Public Works budget and the water system improvements budget which were in the council packet along with the updated loan coverage calculator. Dave Jensen commented that the engineers' errors and omissions insurance should cover issues missed during the water system improvements preliminary engineering. This was an information-only item.
- 3. **Review of Executive Budget** Mayor Schell discussed the updated executive budget that was in the council packet. Past resolutions and minutes related to the salary of the mayor were also in the council packet. Mayor Schell explained that the salary budgeted for FY22 reflected 6 months of the current salary and 6 months of the salary that it would revert back to after December 31, 2021. There was no public comment. This was an information-only item.
- 4. **Review of Capital Improvements Fund** The updated spreadsheet was in the council packet. Clerk/Treasurer Amy Thorngren reported that it included her proposal for funds to replace aging office equipment and funds proposed by Fire Chief Maness for a new fire truck. There was no public comment. This was an information-only item.

## **NEW BUSINESS:**

1. **Review of FY22 Estimated Revenue** – The estimated revenues for all funds was included in the council packet. Clerk/Treasurer Amy Thorngren reviewed each and reported that the certified taxable value used for calculating the mill value was awaited from the state. Dave Jensen asked whether the council packet had been posted on the website. Mayor Schell confirmed that it had. This was an information-only item.

2. **Review of and Schedule Upcoming Budget Meetings** – No additional meetings were scheduled. This was an information-only item.
