MEETING CALLED TO ORDER: Mayor Harris called the meeting to order at 6:30 p.m. Councilmember Ferguson led the Pledge of Allegiance.

PUBLIC COMMENTS: There was no public comment on non-agenda items.

(0:00:55) APPROVAL OF MINUTES: The draft minutes of the November 7, 2023 meeting were included in the council packet. There was no public comment. Councilmember Dahl made a motion to approve the minutes as presented. Councilmember Fiest seconded the motion. The motion passed unanimously

<u>CITY COURT REPORT:</u> City Judge Dennis Loveless was excused.

DEPARTMENTAL REPORTS:

(0:01:25) Administration — Clerk/Treasurer Amy Thorngren reported that the Missouri River Brewing Company had sent the required notice that the paving had been completed from Clark Street to the cul-de-sac; a Toys for Tots donation bin has been placed in the admin office; she attended a meeting at Local Government Services Bureau regarding the FY23 Annual Financial Report; attended the wastewater improvements funding call; and that AARP intended to award the city an Outstanding Community Partner award for the FitLot classes at Kennedy Park.

Police Department – A written report was on the council room table. Police Chief Mike Sanders was excused.

(0:05:00) Public Works – A written report was included in the council packet. Public Works Director Kevin Ore reported that the wastewater connections in Red Fox Meadows

Subdivision had been audited; Robert Peccia & Associates staff were finishing up the city's water and sewer master plans; he met with Cindy Brooks of Montana Environmental Trust Group regarding water rights; he met with the president of the La Casa Grande Subdivision Water and Sewer Association regarding future infrastructure projects; and that the new McClellan Creek water tank is in service. He discussed a map on the council room table depicting proposed city street repair, maintenance, and construction projects and anticipated expenses and funding sources.

Volunteer Fire Department - Fire Chief Troy Maness was excused.

UNFINISHED BUSINESS: There was no unfinished business.

- 1. **(0:20:30)** Living Church of God 2024 Recreation Hall Usage Dates A list of dates was included in the council packet. John Adams expressed his appreciation for the church's continued use of the recreation hall. He discussed the church's hours of operation with Council. There was no public comment. Councilmember Feist made a motion to approve the dates. Councilmember Ferguson seconded the motion. The motion passed unanimously.
- 2. (0:23:20) East Helena Valley Rodeo Association Recreation Hall Fee Waiver Request A copy of the facility use agreement was included in the council packet. Ron Whitmoyer requested the waiver of recreation hall rental fees for the new rodeo grounds construction bid opening meeting. There was no public comment. Councilmember Dahl made a motion to approve the request. Councilmember Feist seconded the motion. The motion passed unanimously.
- 3. **(0:27:30)** Washington Avenue Water Main/McClellan Creek Transmission Main 2023 Summary of Bids A summary of bids was included in the council packet. City Engineer Trevor Larson discussed the bids and recommended approval of Helena Sand & Gravel's bid. There was no public comment. Councilmember Feist made a motion to award the project to Helena Sand & Gravel. Councilmember Dahl seconded the motion. The motion passed unanimously.
- 4. **(0:30:10)** Washington Avenue Water Main/McClellan Creek Transmission Main 2023 Change Order A summary of the change order was included in the council packet. City Engineer Trevor Larson reported that the bids had come in lower than expected and there were funds left over that could be used to extend the transmission main further. There was no public comment. Councilmember Feist made a motion to approve the change order. Councilmember Ferguson seconded the motion. The motion passed unanimously.
