# **PUBLIC COMMENTS:**

(0:08:00) APPROVAL OF MINUTES: The draft minutes of the April 1, 2025 meeting were included in the council packet. There was no public comment. Councilmember Leland made a motion to approve the minutes as presented. Councilmember Feist seconded the motion. The motion passed unanimously.

Councilmember Feist made a motion to approve the proclamation. Councilmember Leland seconded the motion. The motion passed unanimously.
- 2. (0:16:25) FY26 Employee Benefit Elections Employee benefit information for the next fiscal year was included in the council packet. A copy of the current employee benefit elections was on the council room table. Clerk/Treasurer Thorngren noted that there would be a 12.2% cost increase. There was no public comment. Councilmember Feist made a motion to approve the FY26 benefit elections as presented. Councilmember Ferguson seconded the motion. The motion passed unanimously.

(0:18:00) MAYOR'S REPORT: Mayor Harris reported that he had been in discussions in regard to bringing back the annual spring cleanup, infrastructure improvements had begun at the wastewater treatment plant, his water rights response letter had been sent out that day, the last remaining dirt roads in town had been paved, budgeting for FY26 has begun, and that he intends to run for another term.
