

# APPLICATION FOR LANDFILL PERMIT

Effective June 1, 2013, the City of East Helena contracted with its solid waste disposal with Tri-County Landfill, located at 300 Highway 518, East Helena, Montana. East Helena residents are allowed to haul miscellaneous items by presenting their landfill permit. This permit is registered to your property and an account will be established at Tri-County Disposal for you as the permit card holder. In order to create the account, please complete the form below and send it to Tri-County Disposal at the address below.

In addition to the garbage picked-up at your residence by the garbage truck, residents can haul up to 2000 pounds a year (July 1<sup>st</sup> thru June 30<sup>th</sup>) with no additional charge. Disposal weight over the 2,000 pounds will be billed to the permit holder at \$7 for the first 0-200 pounds and over 200 pounds at a prorated tonnage rate of \$39 per ton.

If necessary, a replacement permit can be requested from Tri-County Disposal for a \$ 5.00 fee.

For your convenience, the City has provided recycling bins which are located in the City Hall parking lot at 306 East Main Street. The recyclables are cardboard, paper, steel and aluminum cans.

1. The landfill is open for dumping Monday – Friday & Sunday 8:00AM to 3:00PM. The gate will be locked at all other times & dumping is not allowed outside of these times. If you are caught using the facility after hours, you will be fined.
2. Upon entering the landfill, stop on the scale in front of the scale house. The attendant will punch in the full weight on a three-part ticket. **DO NOT** drive off scale until attendant waves you through. You must give the attendant your name & present your permit. When leaving the landfill, you must weigh out with your empty weight – again remaining on the scale until cleared to leave. You must sign your scale ticket before leaving the landfill. You may ask for a copy of your scale ticket at that time.
3. You are dumping at your own risk. We are not responsible for injuries to you or damage to your vehicles.
4. Cost: \$39.00/ton      Asbestos: \$30/cubic yard
5. Any "Non-sufficient Funds" check returned to us will result in a \$30.00.
