<u>MEETING CALLED TO ORDER:</u> Mayor Harris called the meeting to order at 6:30 p.m. Councilmember Dahl led the Pledge of Allegiance.

(0:02:45) EAST HELENA HIGH SCHOOL ACTIVITIES UPDATE: Activities Director Shaun Murgel updated on sports and events at East Helena High School. This was an information-only item.

(0:04:10) EAST HELENA SUPERFUND UPDATE: Bridget Williams and the EPA/DEQ Site Team Members updated Council on the progress of yard remediation in East Helena. This was an information-only item.

(0:11:05) PUBLIC COMMENTS: Dave Jensen commented in opposition to the condition of the new picnic tables installed at Main Street Park. Mr. Jensen provided pictures and a written version of his comments for the record.

(0:14:20) APPROVAL OF MINUTES: The draft minutes of the November 18<sup>th</sup> meeting were included in the council packet. There was no public comment. Councilmember Dahl made a motion to approve the minutes as presented. Councilmember Leland seconded the motion. Councilmembers Dahl, Leland, and Ferguson voted aye. Councilmember Feist abstained. The motion passed.

<u>CITY COURT REPORT:</u> A written report was included in the council packet. City Judge Dennis Loveless was excused.

### **DEPARTMENTAL REPORTS:**

(0:14:55) Administration – A flyer for Jadyn Fred Foundation was included in the council packet. Clerk/Treasurer Amy Thorngren reported that staff had been decorating for the annual Christmas Stroll and that facility rentals were steadily increasing.

(0:15:30) Police Department – A written report was on the council room table. Police Chief Mike Sanders reported that there had been 520 calls-for-service in November, two new computers were added to the department's office, and that the department was looking forward to the Christmas Stroll.

(0:16:35) Public Works - A written report was included in the council packet. Public Works Director Kevin Ore reported that 99.8 tons of sludge had been processed at the wastewater treatment plant last year, coordinated with City Attorney Elverum to borrow a garbage truck from the City of Deer Lodge until the new truck arrives, and that application for the Federal Highways grant had been submitted on an updated template.

(0:20:35) Volunteer Fire Department - Fire Chief Roger Campbell reported that the department was looking forward to participating in the Christmas Stroll and the Heroes & Helpers program. He noted that Volunteer Firefighter Nick Kallem had been appointed as the department's EMS director.

- (0:21:20) Life Saving Awards for Patrol Officer Kyle Butler & Patrol Officer
  Zach Butler Police Chief Sanders presented lifesaving awards to Officer Kyle
  Butler and Officer Zach Butler for their successful resuscitation of a resident who had
  suffered a heart attack. The survivor was present for the presentation of the awards.
  This was an information-only item.
- (0:25:15) Life Saving Awards for Deputy Police Chief Royce & Patrol Officer
  Zach Butler Police Chief Sanders presented lifesaving awards to Deputy Police
  Chief Ed Royce and Officer Zach Butler for their successful resuscitation of an
  individual who was found not breathing and with no detectible pulse. This was an
  information-only item.
- 3. (0:28:25) Confirmation of Appointment of Patrol Officer Zach Butler Police Chief Sanders discussed Officer Zach Butler's successful completion of his one-year probationary period. There was no public comment. Councilmember Feist made a motion to confirm Officer Zach Butler's appointment. Councilmember Leland seconded the motion. The motion passed unanimously.
- 4. (0:30:35) Robert Peccia & Associates Task Order 30 for Wastewater Treatment Plant Phase 2 Upgrades A copy of the task order was included in the council packet. Mayor Harris noted that a new task order was required for each phase of the ongoing wastewater treatment plant improvement project. (0:31:20) Dave Jensen

- commented in opposition to Task Order 30. Mr. Jensen provided a written version of his comments for the record. Councilmember Feist made a motion to approve Task Order 30. Councilmember Ferguson seconded the motion. The motion passed unanimously.
- 5. (0:35:20) Request to Reissue and/or Cancel Stale-Dated Checks Relevant Montana Code and an example of how the City of Bozeman handles stale-dated checks was included in the council packet. A list of checks proposed to be reissued and/or cancelled was on the council room table. Clerk/Treasurer Thorngren requested Council's approval to write off stale-dated checks per Montana Code 7-6-4303. A final list of the checks to be written off will be presented at the next council meeting. There was no public comment. Councilmember Ferguson made a motion to approve. Councilmember Leland seconded the motion. The motion passed unanimously.

# 1.) WWTP Report

- Prospect continues construction on headworks and lift station.
- Montana Ave Lift pump failed. Crews will be installing back up pump and having failed pump rebuilt. (Discuss)
- Water pump for the Lane Ave lift station generator started leaking. Had to order parts.

# 2.) Metal Removal Building

Shane is doing a great job in operating and maintaining sand filters.

# 3.) Source Water Report

- Service drain line for the M.C. Creek tank started to leak, crews will be making repairs.
   (Discuss)
- Wylie 4 is back into service and running well.
- Shane and I are working with City Engineers on tank water levels and pump run times.
- Shane has finished taking the last water samples for this calendar year.

## 4.) Solid Waste Report

# 9.) Resident/City Information and Events

- Had to remove Christmas lights from Main Street due to power poles not being able to support the weight. Working with N.W. Energy on possible options to repair. (Discuss)
- Yard waste transfer site at the Wastewater Treatment plant is closed for the season. Having trouble with construction material being dumped at off hours. We have changed the gate combo to try to secure this area better. (Discuss)
